First Steps provides 17 therapy services for children from birth up to 3 years old, with developmental disabilities or diagnosed conditions associated with developmental delays. We ensure the family and child receive services in their natural environment, such as home and child care. Children are eligible for services if they exhibit a significant delay in one or more of the following developmental areas: cognition, communication, physical, social-emotional, and adaptive. Children may also be eligible if they have a diagnosed physical or mental condition associated with developmental delays or if the infant was born very premature.
